PROCEDURAL MATTERS

- 1) Grigory Balakin acted as translator for boat Symphony RUS 2113.
- 2) Yannis Kleidonas attended hearing as an observer.

FACTS FOUND

- 1) Boat Symphony RUS 2113 was inspected by the Technical Committee (authorized measurer Dogukan Kandemir) after race no.3
- 2) Boat's IRC certificate no. 35796 was presented during entry the race.
- 3) Technical Committee finds that there is no table in the main cabin of the boat. All standard equipment shall be on board as stated in the certificate.
- 4) Mainsail luff distance P was measured 14,03 m (0,94% more than in certificate). P in certificate is max 13,90 m.
- 5) Boom outer point distance E was measured 4,92 m (0,4% more than in certificate). E in certificate is max 4,90 m.
- 6) Spinnaker pole length SPL was measured 4,22 m (0,96% more than in certificate). SPL in certificate is max 4,18 m.
- 7) Headsail luff distance HLU was measured 14,29 m (3,78% more than in certificate), HLU in certificate is max 13,77 m.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 78.1 IRC rule 8.10.3, 10.2, 13.3

- 1) By not having accurate measurements on the certificate Symphony broke IRC rule 13.3.
- 2) Boat data was re-measured by authorized measurer under IRC rule 10.2.
- 3) In accordance to IRC rule 8.10.3 the boat Symphony is not in compliance with her certificate.
- 4) Symphony is not in compliance with IRC class rules. She broke RRS 78.1.
