The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 [DP] RRS 40.1 applies and is amended so that it applies at all times while afloat.
- 1.3 The following national prescription may require advance preparation:
RRS 46 – Person in Charge – Sail Canada prescribes that the designated person in charge, if resident in Canada, shall be a member of Sail Canada through either a club affiliated to Sail Canada or such person's Provincial Sailing Association.
- 1.4 RRS Appendix T "Arbitration" will apply.

- 1.6 [DP] Protocols related to COVID-19 may be published at any time, state when they will take effect, and will state if they have the status of a rule.

2 SAILING INSTRUCTIONS

- 2.1 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions (SSI) that will be on the online official notice board.

3 COMMUNICATION

- 3.1 The online official notice board is located at: <https://www.racingrulesofsailing.org/documents/3208/event>
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- 4.1 **The event is open to all kiteboards of the Formula Kite (Foiling) and KiteFoil Open classes.**
- 4.2 Eligible kiteboards may enter by completing the online form and submitting it through the event website www.cork.org
- 4.3 **[NP] A kiteboard that sails with a bib number she is not registered with or did not receive permission from the race committee to sail with will receive a 10% scoring penalty as calculated in RRS 44.3(c) added to the race score sailed nearest in time to that of the incident. This changes RRS 63.1.**
- 4.4 **Each Formula Kite (Foiling) competitor shall be registered as a World Sailing Sailor on the World Sailing website and shall be a member of an International Kiteboarding Association (IKA).**
- 4.5 **Formula Kite (Foiling) competitors shall bring their own equipment.**

5 FEES AND REFUNDS

- 5.1 The entry fee covers racing, \$25 per person Sail Canada Regatta fee and a regatta souvenir.
- 5.2 In the case of event cancellation or postponement by CORK, all fees except for bank charges will be refunded.
- 5.3 All fees except for bank charges will be refunded to boats that cancel prior to August 11, 2022.

6 [DP] ADVERTISING

- 6.1 Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.
- 6.2 **Numbered bibs will be provided for competitors which must be worn while racing.**

7 EQUIPMENT INSPECTION

- 7.1 Formula Kite (Foiling) competitors shall submit a completed competitors equipment checklist registration form during competitor check-in prior to 1100 on August 18, 2022.
- 7.2 Kiteboards are required to comply with RRS 78.1 from the time of the first scheduled warning signal until the end of the event.
- 7.3 Upon arriving ashore, a kiteboard may be instructed by a member of the race committee or the technical committee to proceed immediately to a designated area for inspection.
- 7.4 Substitution of damaged or lost equipment will not be allowed unless authorized by the race committee. Requests for substitution shall be made at the first reasonable opportunity.

- 8.1 The race committee may run one extra race on a day provided that they do not get more than one race ahead of the daily schedule and do not exceed the number of races scheduled for the event.

9 VENUE

- 9.1 Sailing will be in Lake Ontario South of Elevator Bay Pier.

10 COURSES

- 10.1 The courses to be sailed will be a windward/leeward configuration suitable for Kites.

11 SCORING

- 11.1 One race is required to constitute a series.
- 11.2 When fewer than four races have been completed, a kiteboard's score will be the total of her race scores.
- 11.3 When from five to ten races have been completed, a kiteboard's score will be her total of her race scores excluding her worst score.
- 11.4 When from eleven to sixteen races have been completed, a kiteboard's series score will be her total of her race scores excluding her two worst scores
- 11.5 When seventeen to twenty three races have been completed, a kiteboard's score will be the total of her race scores excluding her three worst scores.

12 [DP] [NP] SUPPORT PERSONNEL AND VESSELS

- 12.1 Support persons shall register online and if their entry is approved, present a form (Appendix 4) containing the boats they are supporting to the onsite check in point at the boat park.
- 12.2 All support personnel shall comply with CORK's Support Team Regulations <http://www.cork.org/wp-content/uploads/2019/08/Support-Team-Regulations-v1.0.pdf>
- 12.3 Support persons are required to monitor the CORK course channel on their VHF radios and be available to assist with safety when requested. The VHF channel will be stated in the SSI's.
- 12.4 Coaches are expected to attend the coaches meeting each morning. The SSI's may give additional requirements for support persons on the water.

13 [DP] LAUNCHING

13.1 Kiteboards shall launch from and return to Elevator Bay Pier.

14 DISCLAIMER OF LIABILITY AND RISK STATEMENT

RRS 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves and their equipment to such inherent risk whilst taking part in the event.
- (b) They are responsible for the safety of themselves, their equipment, and their other property whether afloat or ashore.
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission.
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate.
- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organizers does not relieve them of their own responsibilities.
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

15 INSURANCE

15.1 Each participating boat shall be insured with valid third-party liability insurance. The organizing authority does not accept any responsibility for verifying that a boat has valid third-party liability insurance.

16 PRIZES

16.1 CORK will provide a variety of prizes depending on the number of competitors in the fleet. Some class associations may provide their own additional prizes.

16.2 Medallions and Helly Hansen prizing will be awarded to the sailors of the top 3 Sail Canada Senior Nationals finishing boats overall.

16.3 Sail Canada Senior Championships awards will be presented by Sail Canada.

16.4 Other awards may be given.
