# **FACTS FOUND**

1. During R4, support boats no. 74, 103 and 127 were positioned above the finishing line starboard layline, in the channel between the waiting area and the finishing area.

## **CONCLUSIONS AND RULES THAT APPLY**

Rules: RRS 63.3(b), 64.5(b), SI 20.4, SI 20.5

1. By being in the centre channel between the waiting area and the finishing area after the warning signal and before all boats had finished or retired or the race committee signalled a postponement, general recall or abandonment, support persons Stefano Cigui, Arkadiusz Lenkowski and Zsofia Weinber breached SI 20.4 and SI 20.5.

- 1. Using the Discretional Penalty Policy, a Penalty Level 1 was applied. There were no circumstances to justify increasing or decreasing the penalty. A warning is issued to support persons Stefano Cigui, Arkadiusz Lenkowski and Zsofia Weinber.
- 2. ITA 8564, ITA 9975, ITA 9636, ITA 9485, ITA 9839, ITA 110, ITA 8998 and ITA 9411 are warned under RRS 64.5(b) (2) that a penalty may be imposed if Stefano Cigui commits a further breach of any rule.
- 3. POL 3952, POL 3954, POL 3956, POL 3526, POL 3630 and POL 2036 are warned under RRS 64.5(b)(2) that a penalty may be imposed if Arkadiusz Lenkowski commits a further breach of any rule.
- 4. HUN 949, HUN 1575, HUN 1634, HUN 1613, HUN 1665, HUN 1664, HUN 1576, HUN 1622 and HUN 1621 are warned under RRS 64.5(b)(2) that a penalty may be imposed if Zsofia Weinber commits a further breach of any rule.
