7. Description Of Incident

We were one of 3 boats approaching windward mark on starboard.

irl 3472 was the most windward boat

Irl 2237 was the middle boat (us).

Irl 4240 the most leeward boat (witness)

We called windward boat on the boat above as we approached the windward mark.

They initially kept clear (approaching the windward mark) , allowing us to keep clear of the boat below.

As IRL 3472 rounded the windward mark, they bore away onto us despite still being the windward boat, we attempted to bear away a little to avoid collision. There was an almost immediate collision between us and the windward boat and also collision between us and the leeward boat, causing damage to our port-side pushpit. These collisions were directly caused by IRL 3472 bearing away onto us.
