PROCEDURAL MATTERS

1. Dan Burden attended the hearing as translator for GER.

FACTS FOUND

- 1. Protest time limit for the Yellow fleet was 18:47
- 2. Protest was lodged at 18:48
- 3. GBR had no internet and needed to use someone else's device to lodge the hearing request.
- 4. The conditions were 10 knots, small waves
- 5. GBR was sailing downwind on starboard on a collision course with GER on port.
- 6. GER began bearing away 2 boat lengths from GBR
- 7. GBR also bore away.
- 8. GBR gybed and immediately after that she capsized.
- 9. Had GBR not gybed then contact would have occurred between GBR bow and GER midships.
- 10. GBR capsized and GBR's sail made contact with GER's boat.
- 11. There was no damage to either boat
- 12. Neither boat took a penalty
- 13. Both boats continued sailing in Race 7

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 10, 14, 62, 61.3

- 1. GBR failed to deliver the protest within the protest time limit, as required by RRS 61.3. However, there was good reason for the PC to extend the time limit under RRS 61.3.
- 2. GER on port failed to keep clear of GBR on starboard and broke RRS 10 and 14.
- It was not reasonably possible for GBR to avoid contact when GBR realized GER was not keeping clear and did not break RRS 14
- 4. GBR's score in race 7 was not made significantly worse through physical damage or injury. Therefore, the requirements for redress in RRS 62.1(b) are not met.
