PROCEDURAL MATTERS

Manfred Bauendahl, the class chief measurer was present since the beginning called by the Int. Jury.

Hearing No. 4 was heard together with Hearing No. 5 in accordance with RRS 63.2 since both hearings arose from very closely connected incidents.

Jury asked the measurer if the protested boats complied with all class rules as changed by the event documents. The measurer requested time to check the equipment to answer the question.

Hearing was reconvened at 11 on 28th July 2022 based on additional request by the chief measurer.

FACTS FOUND

1. Before the start of the event a document from the Class Association Board was published at the official notice board that permit changes the IMCCA class rule 5.3.1.
2. The measurer's answer to the jury question: The protested boats used in race 5 equipment which complies with applicable class rules as modified by the previous document.
