PROCEDURAL MATTERS

The panel of the International Jury was composed in accord-ance with RRS N1.4(b).

Race committee was represented by Salvadori Piergiorgio.

FACTS FOUND

- 1. WIND APPROXIMATELY 15 KTS, HALF METER WAVE HEIGHTS
- 2. FRA 220157 WAS SAILING DOWNWIND ON THIRD LEG OF AN OUTER LOOP ON PORT TACK TOWARDS THE GATE 3P MARK.
- 3. WHEN FRA WAS APPROACHING THE ZONE OF THE MARK, APPROXIMATELY IN TOP 15 OF THE FLEET, BOAT IN FRONT CAPSIZED ON THE MARK, WITH MAIN SHEET ENTANGLED WITH MARK.
- 4. RACE COMMITTEE RIB WITH DRIVER MATEO GIOVANNINI CAME AFTER 20 SECONDS AIMING TO SEPARATE THE CAPSIZED MARK FROM A CAPSIZED BOAT AND BECAME AN OBSTRUCTION TO FRA
- 5. THE MARKS USED AT A GATE WERE BATTERY ENGINE DRIVEN WITH PROPELLERS AND RIB DRIVER STATED IT COULD HAVE BEEN A SAFETY ISSUE AS WELL
- 6. FRA TRIED TO AVOID COLLISION BY BEARING AWAY BUT IT HAS CAPSIZED AND HAD PAIN IN THE BACK AS A CONSEQUENCE.
- 7. FRA CLAIMED HE COULD NOT CONTINUE THE RACE BECAUSE OF INJURY.
- 8. FRA SAILED ON A REACH TOWARDS THE FINISH TO INFORM RACE COMMITTEE ABOUT HIS INTENTION TO REQUEST REDRESS
- 9. FRA RETIRED FROM RACE 5
 - 10. FRA HAS STARTED AND FINISHED BOTH RACE 6 AND 7 IMMEDIATELY AFTER RACE 5 IN SIMILAR CONDITIONS WITH A BIT LESS WIND

CONCLUSIONS AND RULES THAT APPLY

Rules: Preamble of part 2, IRPCAS 18, RRS 62.1

- 1. Race committee RIB made an improper action by interfering with a sailing boat which had right of way and had to comply with IRPCAS 18(a)(iv)
- 2. FRA 's place in race 5 was made worse through her own fault. Therefore, the requirements for redress in RRS 62.1 are not met.
