## **FACTS FOUND**

- 1. Windspeed approx 10kts, Sea state flat.
- 2. 211114 was close hauled on port tack approximately 3/4 up Leg 1. The first 5 boats were close together, each approx 3-5 2 boat lengths apart. The Jury Boat was approximately 2 boat lengths astern following the course of 211114, moving at approx. the same speed as 211114.
- 3. 211114 luffed and passed head to wind onto a close hauled starboard tack course. Approx 5 seconds after the tack was complete, the Jury Boat and 211114 collided. There was no damage or injury.
- 4. 211114 acknowledged that he saw the position of the Jury Boat before he tacked and after the tack was complete.
- 5. At the time of the incident, 211114 was in 1st place.
- 6. When 211114 separated from the Jury Boat, approx 15 seconds had passed.
- 7. 211114 rounded Mark 1 in 4th place. 211114 finished the race in 4th position.

### **CONCLUSIONS AND RULES THAT APPLY**

Rules:

1. By acknowledging the position of the Jury Boat before and immediately after tacking, 211114 was in a position to avoid contact with the Jury Boat. Therefore 211114's place in Race 1 was not, through no fault of her own, made significantly worse by an improper action of the PC.

Redress is not given.
