### **NOTICE OF RACE**

*Mention [DP] in a rule of those SI means that the penalty for a breach of this rule may, at the discretion of the protest committee, be less than disqualification.*

#### **ORGANIZING AUTHORITY (OA)**

The F18 Raid Worlds 2020 will be organised by Club Nautique Wind Force du Robert on behalf of the International Formula 18 Class Association, under the authority of FFV and World Sailing.

#### **1 RULES**

The regatta will be governed by:

- 1.1 The rules as defined in The Racing Rules of Sailing (RRS)
- 1.2 National prescriptions translated for foreign competitors will be joined in appendix "Prescriptions" if necessary
- 1.3 FFVoile Regulations,
- 1.4 If there is a conflict between languages the English text will take precedence.

#### **2 ADVERTISING [DP]**

Boats shall display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.

It is the responsibility of the crew to apply and to maintain the stickers provided by the organization.

All competitors will be requested to wear the bibs provided by the OA over any other piece of clothing.

#### **3 ELIGIBILITY AND ENTRY**

- 3.1 The regatta is open to all boats of following classes :  
Formula 18,  
Formula 16.
- 3.2 Eligible boats can register by completing the form on the Martinique Cata Raid website. [www.martiniquecataraid.com](http://www.martiniquecataraid.com).

Pre-registrations for the Martinique Cata Raid will be open from **August 15, 2019 to 5 October 2019** at the latest, crews must pre-register online by completing the form. Acknowledgment will be sent by email.

**The deadline to confirm registration is 5 October 2019 by transfer a deposit of 100 €; the registration will be final upon receipt of payment by bank**

**transfer, a RIB will be transmitted.** The registration will then be confirmed and sent by email.

The registration fee includes:

- Boat shipping from the following locations
  - Gravelines, France by BCM,
  - Montoir, France by SIRENA,
  - Saint Brieuc, France by SAILFAST CATAMARAN,
  - Miami, Florida, USA,
  - Pointe à Pitre, Guadalupe,
  - Saint Barth, Carribean.
- Accomodation,
- Bus shuttles
- Opening ceremony,
- Lunches,
- Closing ceremony.

Entries are limited to 60 boats

- 10 boats for Carribean,
- 40 boats for Europe,
- 10 boats for USA;

The Organizing Authority reserves the right to increase or not the number of registered boats.

- 3.3 Competitors (each member of the crew) holding a FFVoile license must present at the time of their registration :
- their ClubFFVoile license with a valid "competition" certificate certifying the prior presentation of a medical certificate No contraindication to the practice of sailing in competition
  - or their ClubFFVoile license mentioning "membership" or "practice" accompanied by a medical certificate of no contraindication to the practice of competitive sailing less than a year old,
  - parental authorization for minors
  - if necessary, the authorization to carry advertising
  - the Measurement certificate.
- 3.4 Foreign competitors (each crew member) who do not have a FFVoile license must submit to moment of registration:
- Proof of their membership in a National Authority member of World Sailing,
  - the Measurement certificate,
  - Valid proof of insurance in civil liability with a minimum coverage of 1.500 000 euros,
  - A medical certificate of no contraindication to the practice of sailing in competition dating from less than a year (written in French or English) and parental permission for minors.
- 3.5 The crew must be able to demonstrate their ability to recover the boat after capsize.

#### **4 FEES**

**The registration fee is 450 € per person or 900 € per crew and 700 € if the accommodation is taken care of by the crew.**

**100 € down payment on October 5 2019**

**800 € to pay no later than October 18, 2019.**

In case of withdrawal, the riders will only be reimbursed in case of force majeure (death, serious illness) before 20 October 2019, after a decision by the Organizing Authority who may require a medical certificate or proof. After this date, no refund will be possible. The deposit will not be refunded.

In case of cancellation by a competitor, entry fees will be refunded on grounds of force majeure only, before 20 October deadline, after a decision by the Organizing Authority who may require a medical certificate or proof.

After this date, no refund will be possible.

In any case, deposit will not be refunded.

#### **5 SCHEDULE**

##### **5.1 Registration:**

January 24<sup>th</sup> and 25<sup>th</sup>. From 09:00 to 16:00.

##### **5.2 Equipment inspection and stamping:**

January 24<sup>th</sup> and 25<sup>th</sup>. From 09:00 to 16:00.

##### **5.2 Opening Ceremony:**

January 25<sup>th</sup> at 19:00

##### **5.3 Races**

A practice race and 5 course legs are planned in the program, the number of races run is left to the appreciation of the Race Committee which may, depending on weather conditions or any other unfair considerations for all, modify the initial program.

All races run and validated are taken into account for the final ranking.

January 26<sup>th</sup> 13:00: Skippers meeting.

14:00: Warning signal for Practice Race

January 27<sup>th</sup> 09:00: Skippers meeting.

10:00: Warning signal for 1<sup>st</sup> leg Schoelcher-Sainte Anne

January 28<sup>th</sup> 09:00: Skippers meeting.

10:00: Warning signal for 2<sup>nd</sup> leg Sainte Anne-Wauclin

January 29<sup>th</sup>: Reserve Day

January 30<sup>th</sup> 09:00: Skippers meeting.

10:00: Warning signal for 3<sup>rd</sup> leg Wauclin-Trinité

January 31<sup>st</sup> 09:00: Skippers meeting.

10:00: Warning signal for 4<sup>th</sup> leg Trinité-Prêcheur

February 1<sup>st</sup> 09:00: Skippers meeting.

10:00: Warning signal for 5<sup>th</sup> leg Prêcheur-Schoelcher

February 2<sup>nd</sup>: Containers loading

##### **5.4 A skippers meeting will be held one hour before the day's warning signal.**

Every boat must be represented at this briefing.

##### **5.6 On the last scheduled day of racing no warning signal will be made after 16:00, except after a general recall.**

## **6 MEASUREMENT**

- 6.1 Competitors shall produce valid measurement certificates at the time of registration.
- 6.2 Boats may be subject to inspection at any time during the event.
- 6.3 All boats shall carry national letters on their sails.
- 6.4 The equipment limitations as specified in the class rules shall apply.

## **7 SAILING INSTRUCTIONS**

The sailing instructions will be downloadable on event website <https://martiniquecataraid.com> by 16<sup>th</sup> December, and printed copies will be available at final registration January 24<sup>th</sup> and 25<sup>th</sup>.

## **8 THE COURSE**

- 8.1 The courses will be long distance and / or windward/leeward.
- 8.2 The racing area extends around Martinique.
- 8.3 It is own responsibility of competitors to get relevant nautical documents (For information, Nautical Charts SHOM n° 6738 Martinique South Part, n°7041 Martinique North Part).

## **9 PENALTY SYSTEM [DP]**

- 9.1 Penalty for breaking a rule of RRS chapter 2 are replaced as follows:
  - 9.1.1 The 2 turns penalty is replaced by a one-turn penalty. The turn includes one tack and one gybe. This changes rules RRS 44.2.
  - 9.1.2 A boat that took a penalty according to rule RRS 44.1 must fill in a form to acknowledge it to the race committee secretary before the protest time limit.
- 9.2. Penalty for infringing rules 29.1, 30.1, 30.3 or 30.4 will be defined as follows:
  - OCS: boat racing time + 10 minutes (this changes RRS 29.1, 30.1 & A4),
  - UFD: boat racing time + 20 minutes (this changes RRS 30.3),
  - BFD: boat racing time + 30 minutes (this changes RRS 30.4).
- 9.3. Penalty for not signing out, signing in or for not attending skippers meeting: boat racing time + 15 minutes.
- 9.4 When breaking a rule not defined in chapter 2 of RRS nor listed in a rule of this Notice of Race, the boat will receive a penalty from 10% of the racing time of the last boat to finish and complete the course to DSQ penalty, at the discretion of the Jury.
- 9.5 The Jury keeps the right for disqualifying a boat.

## 10. RANKING

Official rankings of the event:

- An F18 ranking will be made by addition of elapsed race time for each race that have been sailed and validated, corrected if necessary by any bonuses or penalties applicable.
- The title of RAID WORLD CHAMPION will be awarded for the F18 class.
- First Mixed Team in F18 Class will be awarded Sandra Tartaglino Perpetual Trophy
- An F16 ranking will be made by addition of elapsed race time for each race that have been sailed and validated, increased if necessary any bonuses or penalties applicable.
- Special Prix Martinique Cata Raid, a general scratch (unofficial) classification of all the classes present will be performed by adding the compensated times of the races run and validated; corrected by any bonuses and penalties.

## 11 RADIO COMMUNICATION [DP]

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. Messages may only be emitted on the race channel.

## 12 SAFETY

12.1. The mandatory safety equipment on board is as follows:

- 1 paddle of at least 1 meter long,
- 1 towing line, ready for use, 15<sup>m</sup> long and 6<sup>mm</sup> diameter,
- 1 righting line, ready for use, 3,5<sup>m</sup> long and 10<sup>mm</sup> diameter,
- 2 Personal floatation devices approved (CEE or PFD),  
Length and diameters from this rule are only minimums and might be exceeded.
- 1 working watertight VHF,
- 1 bearing compass,
- 2 individual waterproof flash lights.
- 1 transponder provided by the OA

12.2. The following equipment are permitted:

- GPS,
- Electronic compass.

12.3 Any team missing one safety equipment defined in 13.1 can be DSQ

12.4. All safety equipment shall be presented at first skippers meeting.

## 13 PRIZES

Prizes will be awarded during closing ceremony on 1<sup>st</sup> February evening.

## 14 DECISION TO RACE - DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk, see Fundamental Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 15 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance, including coverage when racing at the venue of the Championship, with a minimum

cover of 1.500.000 Euros per event or the equivalent. This document shall be in French or English language.

## **16 MEDIA RIGHTS**

- 16.1 By sailing this event a competitor automatically grants to the Organizing Authority and the sponsors of the event the right in perpetuity to make, use and show from time to time and at their discretion, any motion or still pictures, and live, taped or film television and any other reproductions of him/her during the period of The Martinique Cata Raid in which the competitor competes and in all material related to The Martinique Cata Raid without any compensation.

## **17 FURTHER INFORMATION**

- 17.1. OA will provide competitors with 4 containers leaving France. Three loading spots are selected :
- Gravelines, by Emmanuel Boulogne Concept,
  - Montoir, by SIRENA
  - Saint Briec, by SAILFAST
- Loading date will be precised later.  
Related to Pointe à Pitre or Saint Barth loading places, OA will precise the partner shipping company later.
- 17.2. Mandatory documents to present before loading containers:
- Boat bill,
  - Certificate of origin
  - Detailed packing list,
  - Copy of owner's ID
- 17.3 Accomodation will be provided by the OA. Different packages will be offered (full pension, half pension or homestay).  
For teams managing accomodation by their own, registration fee will be lowered by 200 euros. However, those team would have to inform OA by 18<sup>th</sup> October at the latest.
- 17.4 For accompanying people, OA will propose packages for accomodation, lunches, and spectator boat.  
Preferred prices will be offered for renting cars. It is highly recommended to book a car as soon registration is validated.
