This Race is held by under the T.C. Ministry of Health and Turkish Sailing Federation's COVID-19 Guidelines

- > The notation [DP] in a rule in the NoR means that the penalty for a breach of that rule may be less than disqualification at the discretion of the International Jury.
- The notation [NP] in a rule in the NoR means that infringement of this rule shall not be protested by boats.

1. ORGANISING AUTHORITY

- 1.1. The organizing authority of this event is Marmaris International Yacht Club (MIYC)
- 1.2. Race Office will be placed at Marmaris International Yacht Club,

2. RULES

- 2.1. The "Rules" as defined in Racing Rules of Sailing (RRS) of the World Sailing 2017-2020
- The World Sailing Offshore Special Regulations 2020.
- The World Sailing Regulation 20 (Advertising Code).
- 2.4. IRC Rules 2020, Parts A, B, C.
- 2.5. The International Regulations for Preventing Collisions at Sea (IRPCAS) will prevail over the RRS from sunset to sunrise.
- 2.6. The sunrise time 0725 (local) hrs. and sunset time is 1815 (local) hrs. for the Race Week
- 2.7. No national authority prescriptions will apply.
- 2.8. The official language of the event will be English.
- 2.9. If there is a conflict between the rules above, the Notice of Race, the Sailing Instructions and its amendments will be valid according to their date. This changes RRS 63.7.
- 2.10. The organizing authority or the race committee may reject or cancel the entry of a boat or exclude a competitor provided it does so before the start of the first race and states the reason for doing so (RRS 76.1).
- 2.11. All those registered are deemed to have accepted all the rules stated in the Notice of Race.

3. RACE CATEGORY [NP]

3.1. Race category for inshore races (R#1 to R#4 and R#6) will be OSR App. B,

3.2. Race category for offshore race (R#5) will be OSR Mo.Cat-3 with liferaft.

4. ADVERTISING [NP]

- 4.1. Boats may display advertising in accordance with Word Sailing Regulations 20, Advertising Code.
- 4.2. Boats, which have the approval of their national authority, shall submit a copy of the approval to the Race Office on registration.
- 4.3. Charter companies' names, signs and logos are acceptable.
- 4.4. The organizers may require competitors to display event sponsor's advertising material. Stickers will be supplied at registration. These shall be affixed according to organizer's instructions.

5. **ELIGIBILITY [NP]**

- 5.1. The regatta is open to all monohull sailing boat with,
 - 5.1.(a). Holding a valid 2020 IRC Rating Certificate,
 - 5.1.(b). LH/LOA between min.7 to max.30 m
 - 5.1.(c). Having inboard or outboard engine with sufficient fuel.
 - 5.1.(d). However, only for Offshore Race;
 - 5.1.d.1. Boats with an outboard engine shall not be allowed to participate the offshore race.
 - 5.1.d.2. Boats with an outboard engine shall be scored as DNC (did not come) for the offshore race.
- 5.2. No boat shall be eligible to enter and race without a valid 2020 IRC rating certificate. TCC value on IRC certificate will be used. TCC (No Spinnaker) value will not be used.
- 5.3. If a boat does not have a valid 2020 IRC rating certificate, application to MIYC Office by 15th October 2020 may secure it.

6. **CREW LIMITATION [NP]**

- 6.1. The regatta is open to all sailors who comply with the World Sailing Eligibility Code. Competitors must be eight (8) and older.
- 6.2. All competitors except foreign nationals shall have a sportsman's license valid for 2020.







- 6.3. Each skipper shall submit a crew list attached to his or her "Race Entry Form".
- 6.4. There will be no upper crew limitation, but a minimum crew of three (3) (two of them minimum 16 years of age) is required.
- 6.5. Every change of a crew member shall be declared to the Race Office no later than two(2) hours before the respective time of the start. [DP]

7. ENTRY

- 7.1. Eligible boats may enter the **Online Entry Form** duly completed from to
 - www.marmarisraceweek.com
- 7.2. Entries shall be submitted to the MIYC no later than 23thOctober 2020, 1700 (local) hrs.
- 7.3. To be entered a competitor shall have completed the following as described below;
 - 7.3.(a). Fulfilled Entry Form,
 - 7.3.(b). Crew list, licence no (For Turkish Citizens only) and World Sailing Sailor ID (IF ANY).
 - 7.3.(c). COVID-19 Personal Location Form. (Attached)
 - 7.3.(d). ID copies of all competitors,
 - 7.3.(e). Mandatory Health Report for *65 and older*.
 - 7.3.(f). Registered with the OA, including payment of all fees,
 - 7.3.(g). 2020 IRC Certificate on file with the OA,
 - 7.3.(h). Advertisement permit/certificates must be send to miyc@miyc.org
 - 7.3.(i). For Charter classes only;
 - 7.3.i.1. A Charter Licence, valid on the dates of Marmaris International Race Week should be submitted to the registration office.
 - 7.3.i.2. A **Charter Agreement**, valid on the dates of Marmaris International Race Week, with an entry form should be submitted to the registration office. The mentioned agreement should be either under the name of the person who is in charge or a crew member of the boat.

8. FEES

- 8.1. The entry fee for boats shall be as follows;
 - 8.1.(a). (LOA) between 07.00 to 11.99 meters, EUR600
 - 8.1.(b). (LOA) between 12.00 to 14.99 meters, EUR700
 - 8.1.(c). (LOA) 15.00 meters and above, EUR800
- 8.2. Charter companies will pay an additional EUR100 per chartered boat as a contribution to the Race Week organization.

- 8.3. IRC 2020 measurement and Rating Certificate fee is to be charged according to the valid IRC Price Lists.
- 8.4. A deposit of EUR50 will be charged for the class signs and flags, which is refundable at the end of the regatta.
- 8.5. Protest fee shall be EUR200.

9. CLASSES & HANDICAP SYSTEM [NP]

- 9.1. The boats entered to the regatta will race in;
 - 9.1.(a). IRC and,
 - 9.1.(b). IRC CHARTER Classes.
 - 9.1.b.1. The boats may categorized by AO as Racer Cruiser, Racer Cruiser Performance or/and any performance version by the manufacturers will be considered on determination of IRC CHARTER

PERFORMANCE

- 9.2. Time on Time (TOT) system will be applied.
- 9.3. The TCC value on the IRC certificate will be used. (No Spinnaker value shall not be used.)
- 9.4. Any charter boat can race in IRC divisions (according to RC's approval) but not vice versa.
- 9.5. Class/Division determination is made by MIRW Organization Committee in accordance with the TCC of the registered boats in their groups. It is final and can't be contested.
- 9.6. OBLIGATIONS AND RESTRICTIONS FOR IRC CHARTER CLASSES. [DP]
 - 9.6.(a). All the present charter equipment shall be on board:
 - 9.6.a.1. All standard furniture,
 - 9.6.a.2. All security equipment,
 - 9.6.a.3. At least one (1) un-modified anchor that meets the anchor manufacturer's recommendation based on the boat's dimensions with suitable combination of chain and rope, ready for immediate assembly, and ready for deployment within 5 minutes.
 - 9.6.a.4. Either an inboard or outboard engine, with associated tanks and fuel supply systems, all securely fastened
 - 9.6.a.5. Warps, spare petrol and water jerry cans, galley utensils, gas bottles, fire extinguishers etc.
 - 9.6.a.6. Dinghies, outboard engines, biminis and spray hoods can be taken out.

10. REGATTA PROGRAMME & RACE SCHEDULE

- 10.1.31th MIRW 2020 Regatta Programme;
 - 10.1.(a). Online Registration Until 23 October 2020 at 1700 (local) hrs.
 - 10.1.(b). Training Day: 24-25 October 2020







- 10.1.(c). Regatta Documents 25 October 2020 at 1600 (local) hrs. will be delivered at MIYC office.
- 10.1.(d). Skipper Briefing: According to Covid-19 precautions there will be no any skipper briefing. All information will be post on the official board.

10.2. Race Schedule;

10.2.(a). Five (5) Inshore and one (1) offshore race are scheduled

- 10.3. If the 2nd race could not be held for any reason on the first day of the regatta, race will be held on the 2nd or 3rd Race Day. The race committee will use VHF to communicate race information, like its intention to start another race. Delay in the radio communication of these calls, or the order in which they are made, or any omission or failure in the emission or reception of these calls, shall not be grounds for a request for redress (modifies RRS 62.1(a)).
- 10.4. The Race Committee will decide whether Race #6 will be sailed or not, depending on the finishing time of Race #5. The decision will be posted on the notice board latest by 0830 (local) hrs. on the 30 October 2020.
- 10.5. If the Race #6 will not be sailed this shall not be grounds for a request for redress.
- 10.6. On the last racing day, there will be no warning signal for the first division/s after 1400 hrs. (local) except after a general recall of division/s, whose first warning signal was given before 1400 hrs.

11. SAFETY AND LIFE SAVING EQUIPMENT (NP)

- 11.1. In twentyfive (25) knots wind speed, the Race Committee may decide not to start the race/may finish an already started race or shorten the race course/may abandon the race. None of those options shall be grounds for redress.
- 11.2. For all Races; Competitors' attention is drawn to RRS 1.2 life-saving equipment: "Each Competitor is individually responsible for wearing a personal flotation device adequate for the conditions."
- 11.3. For Race #7, in Offshore Race a combined Lifejacket and Harness shall be worn when on deck:
 - 11.3.(a). Between the hours of sunset and sunrise
 - 11.3.(b). When alone on deck

- 11.3.(c). When reefed
- 11.3.(d). When the true wind speed is 25 knots or above
- 11.3.(e). When the visibility is less than 1 nautical mile.
- 11.4. According to Covid_19 precautions all participants are requested to wear face coverings where and when appropriate.

12. RACE AREA

- 12.1. The races will be held in Marmaris Bay & Gulf of Fethiye.
- 12.2. There will be two separate race areas to which classes will be assigned, inside and outside of the Marmaris Bay.
- 12.3. Turkish Chart Nr. 312, 313B, 3121A and appropriate Admiralty Charts are recommended.

13. SAILING INSTRUCTIONS & THE COURSES

- 13.1. The Sailing Instructions will be available from 1600 (local) hrs. on 25 October 2020, at the Race Office.
- 13.2. The course charts will be delivered with the Sailing Instructions.

14. SCORING & NUMBER OF RACES (NP)

- 14.1. The Low Point Scoring System (RRS A4) will be applied.
- 14.2. Five (5) inshore and one (1) offshore races are scheduled. The organizing authority has the right to change the number of races.
- 14.3. The regatta is valid if at least two (2) races are completed.
- 14.4. One (1) discard will be allowed if five (5) inshore races are completed, but offshore race shall not be discarded.
- 14.5. The winner will be the boat with the lowest total points.
- 14.6. In case of a tie between boats, RRS A8 will be applied.

15. RADIO COMMUNICATION

- 15.1. It is mandatory to have a VHF marine radio and to keep it on during the races.
- 15.2. The Race Committee intends to make courtesy broadcasts to competitors on Marine VHF radio.
- 15.3. The specific channels for each racing area will be stated in the sailing instructions.
- 15.4. Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile phones (voice and/or data transmissions. [DP]

16. INTERNATIONAL JURY

16.1. An International Jury will be constituted under RRS App. N and its decisions will be final as provided in RRS 70.5







17. MEASUREMENT CHECKS & INSPECTION

- 17.1. Each boat shall provide a valid 2020 IRC certificate.
- 17.2. If requested, a team provided by MIYC may carry out the measurements.
- 17.3. The boats may be measured before or after any race even without a need for protest.
- 17.4. All skippers must ensure that their boat complies with Word Sailing Offshore Special Regulations and their inventory includes all equipment for "Category 3 mo.with liferaft for offshore race and Category Appendix B for inshore races" defined by above rule. [DP]
- 17.5. Boat's inventory may be randomly inspected in marina or on the water by inspectors appointed by the Race Committee.
- 17.6. After 20th October 2020, 1700 (local) hrs. any modification request for IRC will not be accepted.

18. BERTHING

- 18.1. Participating boats may moor in Netsel Marina free of charge, from 24 October 2020 at 1200 (local) hrs. till 31 October 2020 at 1200 (local) hrs. After races, boats returning to the Marina shall call marina authority on VHF Channel 72 for berthing instructions. Due to high number of participants, mooring may need to be alongside other boats. Usage of these moorings will be under skipper's / owner's responsibility.
- 18.2. For berthing needs longer than the period stated in article 18.1, the current fees of Netsel Marina will be applied.
- 18.3. Marmaris Netsel Marina is an open marina and is not responsible for the safety of boats. Each boat owner / lessee is responsible for ensuring the safety of his/her boat and taking the boat to a secure marina or bay. In addition, any other risks that may occur whilst moored in Netsel Marina during time stipulated above are the responsibility of the participants and Netsel Marina accept no responsibility.
- 18.4. Marmaris Netsel Marina must be supplied with the following documents on arrival of the boats 18.4.(a). Port Registration deed or Custom

Boat Registration Certificate or Certificate of Cer

18.4.(b). Permit Range (Transit Log) 18.4.(c). Insurance Policy

19. HAUL-OUT RESTRICTIONS

- 19.1. By 0800 (local) hrs. on 26 October 2020 all boats shall be afloat. [DP]
- 19.2. Hauling out after this time shall be done only after a written permission by the Race Committee according its terms

20. DIVING EQUIPMENT AND PLASTIC POOLS

20.1. Without prior written permission of the Race Committee, underwater breathing apparatus and plastic pools or their equivalent shall not be used around any participating boat between the preparatory signal of the first race and the end of the Regatta. [DP]

21. PRIZES

- 21.1. After each race, all classes/division will be awarded 1st, 2nd and 3rd.
- 21.2. At the end of 31st Marmaris International Race Week, the three best scoring boats in each class/division will be awarded overall 1st, 2nd and 3rd.
- 21.3. Additional prizes will be awarded according to MIYC decisions.

22. RISK STATEMENT

- 22.1. Competitors and support team participate in the series entirely at their own risk and they are reminded of the provisions of RRS 4, Decision to Race. Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
 - 22.1.(a). They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event,
 - 22.1.(b). They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore,
 - 22.1.(c). They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
 - 22.1.(d). By participating in any race, they are satisfied that their boat is in good order, equipped to sail in the event and they are fit to participate;
 - 22.1.(e). The provision of a race management team, patrol boats, umpires and other officials and volunteers by the organizer does not relieve them of their own responsibilities;
 - 22.1.(f). The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
 - 22.1.(g). It is their responsibility to familiarize themselves with any risks specific to this venue or this event drawn to their







attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

22.2. MIYC, International Jury, Race Committee and all parties involved in the Race Week organization will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the Race Week.

23. INSURANCE

23.1. Each participating boat and the crew must be insured with sufficient insurance cover to meet all or any claims and third party coverage. Boats shall have adequate and suitable insurance before racing.

24. PRESS CENTER

24.1. Press members who would like to follow the regatta are kindly asked to have an

accreditation. For accreditation please contact MIYC office.

25. RIGHTS TO USE NAME AND LIKENESS

25.1. In participating, a competitor automatically grants to the Organizing Authority and the sponsors, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of competition in which the competitor participates and in all material related to the said Event without compensation.

- 26.1. Social events schedule will be announced later.
