# SAILING INSTRUCTIONS

All the participants to regatta's activities are conscious of prescriptions regarding the containment and the contrast of COVID 19, written in the Italian Sailing Federation (FIV), and they commit to follow them in the consciousness that potential negative behaviors are against these specific dispositions and they can be noticed and reported to the Authority in charge by the Organizing Committee.

DP Rules for which penalties are upon the Protests Committee. Depending on the seriousness of the breach of point 1.h, the penalty may be from a minimum of 10% to a disqualification.

NP Rules that may not be ground of protests between boats (this changes RRS60.1(a))

### 1. RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.

1.2 RRS Appendix P, *Special Procedures for Rule 42*, will apply as amended by SI 15.2

1.3 The 29er Eurocup Notice of series 2020

1.4 National prescriptions (FIV guidelines) will apply 4(b), 6, 8,9,11 & 12

1.5 If there is a conflict between languages the English text will take precedence.

1.6 The "PROTOCOLLO DI REGOLAMENTAZIONE DELLE MISURE PER IL CONTRASTO ED IL CONTENIMENTO DELLA DIFFUSIONE DEL COVID-19 NELLE SOCIETÀ E ASSOCIAZIONI SPORTIVE AFFILIATE", the update version on the 14th June or upcoming, is defined from here on as "protocol". A breach of protocol may be a [DP] breach. In particular, all the persons involved, found without the needed PPE (masks), as said in the "protocol", could be summoned by the PC, as per the RRS 60.3(d), with all the boats supported, as per definition of "part of the hearings".

### 2. ADDITIONAL IDENTIFICATION [NP]

While racing each boat shall display a coloured placard corresponding to the fleet to which

she has been assigned and inserted in the sail pocket near the clew of the mainsail. Placards will be available from the race office.

### 3. NOTICES TO COMPETITORS

Notices to competitors will be posted on the official notice board, located at the Race office.

### 4. CHANGES TO SAILING INSTRUCTIONS

Any change to the sailing instructions will be posted not less than 30 minutes before flag D is displayed (SI 5.2), except that any change to the schedule of races will be posted by 20:00 hours on the day before it will take effect. Up to FOUR races a day may be sailed without the need for a change in Sailing Instructions

### 5. SIGNALS MADE ASHORE

- 5.1 Signals made ashore will be displayed on the flag pole located on the terrace. When a signal is displayed over a fleet flag it applies to that fleet only.
- 5.2 [DP][NP][SP] Flag D with one sound means: "The warning signal will be made not less than 60 minutes after flag D is displayed". Boats shall not launch until this signal is made.

### FORMAT OF RACING

- 6.1 The regatta will consist of a Qualifying series and a Final series.
  - (a) If the number of entries is equal to or less than 65 boats, only one start will be given
  - (b) If the number of entries is more than 65, the event may be run in fleets with a qualifying and a final series, as defined below.
  - (c) FOUR races are required to be completed by each fleet to validate the regatta.
- 6.2 **Qualifying Series:**
  - (a) For the Qualifying series boats will be assigned to fleets Yellow, Blue, of, as nearly as possible, equal size and ability. Initial fleet assignments will be made by a seeding committee appointed by the Class, and posted by 11:00 on the first day of racing.
  - (b) In the Qualifying series boats will be reassigned to fleets after each day of racing, except if on the first day only one race is completed. If all fleets have completed the same number of races, boats will be reassigned on the basis of their ranks in the series. If all fleets have not completed the same number of races the series scores for reassignment will be calculated for those races, numbered in order of completion, completed by all fleets. Reassignments will be made as follows;

| <b>Rank in series</b> | <b>Fleet assignment</b> |
|-----------------------|-------------------------|
| First                 | White                   |
| Second                | Green                   |
| Third                 | Green                   |
| Fourth                | White                   |
| Fifth                 | White                   |

and so on

- (c) If all fleets have not completed the same number of races by the end of a day, the fleets

with fewer races will continue racing the following day until all fleets have completed the same number of races. All boats will thereafter race in the new fleets.

### 6.3 Final Series:

- (a) Boats will be assigned to the Final Series fleets Gold, Silver, on the basis of their ranks in the Qualifying Series. The boats ranked highest in the Qualifying Series will be assigned to the Gold fleet. The next boats in the Qualifying Series will be assigned to the Silver fleet.
- (b) Any recalculation of Qualifying Series rankings after boats have been assigned to Final Series fleets will not affect the assignments except that a redress decision may promote a boat to a higher fleet.
- (c) Each final series fleet will be scored separately. Different final series fleets need not have completed the same number of final races. The boats in the Gold fleet will be ranked highest, etc.

## 7. SCHEDULE

7.1 14 Races are scheduled as follows:

- 24 October from 8.30 to 11.00 Registration
- 24 October at 10.00 Skipper briefing live on Facebook
- at 12.00 First warning signal
- 25 October Race(s)
- 26 October Race(s)
- 27 October Race(s) – Prize Giving  
as soon as possible after the end of the last race

7.2 The scheduled time of the warning signal for the first race each day is 12.00

7.3 On 27th October there will be no warning signal after 15.00

7.4 Up to FOUR races per day are scheduled.

7.5 TWO days qualifying races and TWO days Final races are scheduled

7.6 A coaches' briefing is scheduled for 11.00 each race day.

## 8. CLASS FLAGS

Class flags will be the class insignia on a coloured flag are as follows:

| Qualifying fleets | Final fleets   | Flag colour |
|-------------------|----------------|-------------|
| White             | White (gold)   | White       |
| Green             | Green (silver) | Green       |

## 9. RACING AREA

Attachment A shows the location of racing areas.

## 10. THE COURSE

10.1 The diagram in Attachment B shows the course, including the course signals, the order in which marks are to be passed, and the side on which each mark is to be left.

10.2 No later than the warning signal the course signals and the approximate compass bearing

of the first leg will be displayed on a board on the start line committee boat.

10.3 A gate maybe replaced by a single mark to be left to port

10.4 Races will not be shortened using flag S. This changes RRS 32.

## 11. MARKS

11.1 Marks 1..... Yellow

Mark 2S and 2P Yellow

Change mark .....Yellow

11.2 Starting mark will be Red

This mark may be replaced by a race committee vessel displaying an orange flag.

11.3 Finishing Mark will be a little buoy with an orange flag.

## 12. THE START

12.1 The starting line will be between staff displaying orange flag on the race committee vessel and the Starting mark.

12.2 [DP][NP] Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.

12.3 A boat starting later than 4 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A4 and A5.

12.4 To alert boats that a race or sequence of races will begin soon, the orange starting line flag will be displayed with ONE sound signal not less than TWO minutes before the warning signal is displayed.

## 13. CHANGE OF THE NEXT LEG OF THE COURSE

To change the next leg of the course, the race committee will lay a new mark and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced by an original mark.

## 14. THE FINISH

The finishing line will be between staffs displaying a blue flag on the race committee vessel and the finishing mark.

## 15. PENALTY SYSTEM

15.1 RRS Appendix P, *Special Procedures for Rule 42*, will apply as amended by SI 15.2.

15.2 RRS 44.1 is changed as follows. The penalty under RRS P2.1 shall be a One-Turn Penalty. RRS P2.2 is changed so that it will apply to any penalty after the first one. RRS P2.3 will not apply.

## 16. TIME LIMITS AND TARGET TIMES

16.1 Time limits and target times are as follows:

| Time limit | Target time |
|------------|-------------|
| 45 minutes | 30 minutes  |

16.2 If no boat has finished within the Time limit the race will be abandoned. Failure to meet the target time will not be grounds for redress. This changes RRS 62.1(a).

16.3 Boats failing to finish within 15 minutes after the first boat sails the course and finishes will

be scored Did Not Finish without a hearing. This changes RRS 35, A4, and A5.

## **17. PROTESTS AND REQUESTS FOR REDRESS**

- 17.1 Protest forms are available at the race office. Protests and requests for redress or reopening shall be delivered there within the appropriate time limit.
- 17.2 The protest time limit is 90 minutes after the last boat has finished the last race of the day, or the race committee signals no more racing today, whichever is later.
- 17.3 Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held in the protest room, located on the first floor of the Race Office.
- 17.4 Notices of protests by the race committee or jury will be posted to inform boats under RRS 61.1(b).
- 17.5 A list of boats that, under SI 15.2, have been penalized for breaking rule 42 will be posted.
- 17.6 Breaches of SIs 2, 5.2, 12.2, 20, 22, 23, 25, 26, 27, 28, 29 and 30 will not be grounds for a protest by a boat. This changes RRS 60.1(a). Penalties for these breaches may be less than disqualification if the jury so decides.
- 17.7 On the last scheduled day of racing a request for redress based on a jury decision shall be delivered no later than 30 minutes after the decision was posted. This changes rule 62.2.

## **19. SCORING**

- 19.1 The low point scoring system of Appendix A, as changed below, will apply to the Qualifying Series races.
- 19.2 For all fleets, FOUR Qualifying Series races are required to be completed to constitute a series.
- 19.3 When less than FOUR races have been completed, a boat's Qualifying series score shall be the sum of her race scores.
- 19.4 When FOUR or more Qualifying races have been completed, a boat's Qualifying series score shall be the sum of her race scores excluding her worst score. When less than FOUR Final Series races have been completed, a boat's Final series score shall be the sum of her race scores.
- 19.5 When FOUR or more Final Series races have been completed, a boat's Final series score shall be the total of her race scores excluding her worst score.
- 19.6 When RRS A4.2 and A5 apply, a boat's penalty score shall be based on the number of boats in the largest group. This changes RRS A4.2 and A5.
- 19.7 Final Series fleets need not have completed the same number of races.
- 19.8 The Qualifying Series score plus the Final Series score will be the overall points for the Championship

## **20. SAFETY REGULATIONS [DP][NP][SP]**

20.1 Competitors shall wear personal flotation devices adequate for the conditions. Flag Y will not be displayed. This changes RRS 40.

20.2 A boat that retires from a race shall notify the race committee as soon as possible.

20.3 Under all circumstances coaches and other support boats are expected to assist any boat in distress.

20.4 When Flag V is displayed by the race committee signal vessel, coach and other support boats will collaborate with the race committee in rescue tasks.

## **21. REPLACEMENT OF CREW**

21.1 Substitution of competitors will not be allowed without prior written approval of the race committee.

21.2 Substitution of damaged or lost equipment will not be allowed unless approved by the race committee. Requests for substitution shall be made to the committee at the first reasonable opportunity.

## **22. EQUIPMENT & MEASUREMENT CHECKS [DP][NP]**

22.1 A boat or equipment may be inspected at any time for compliance with the class rules and sailing instructions. On the water, a boat can be instructed by a race committee equipment inspector or measurer to proceed immediately to a designated area for inspection.

22.2 Only one set of sails and one forestay may be used during the regatta.

## **23. ADVERTISING [DP][NP][SP]**

Boats shall display the advertising supplied by the Organising Authority on both sides of the forward 25% of the hull and on the boom.

## **24. OFFICIAL BOATS**

Official boats will be identified as follows:

Race committee boat

Club Flag

Jury boats..... White flags with JURY

Technical Committee / measurement boats..... White flags with letter "M"

## **25. SUPPORT BOATS [DP][NP]**

25.1 Support boats shall be registered with the Organising Authority and will be required to comply with local legislation and the 29er Class Support Boat Regulations (see International Class website under Events and Race Management)

25.2 Team leaders, coaches and other support personnel shall stay outside areas where boats are racing from the time of the preparatory signal until all boats have finished or retired or the race committee signals a postponement, general recall or abandonment.

25.3 Support boats shall be marked with a flag with S supplied by the club

25.4 If called upon support boats will be required to act as rescue boats.

## **26. CODE OF CONDUCT [DP][NP]**

Competitors and Support persons shall comply with any reasonable request from a regatta official or member of the Organising Authority. Boats shall follow all instructions given by the



OA when returning to shore to avoid overcrowding at the launching ramps.

**27. TRASH DISPOSAL [DP][NP]**

Trash may be placed aboard support and race committee boats.

**28. BERTHING [DP][NP]**

Boats shall be kept in their assigned places in the boat park.

**29. RADIO COMMUNICATION [DP][NP]**

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction includes mobile telephones.

**30. ELECTRONIC EQUIPMENT [DP][NP]**

No competitor or support team shall use a drone over the racing area. However a drone may be flown by a licensed company authorised by the Organising Authority to record video and still imagery exclusively for advertising and promotion.

**31. PRIZES**

See Notice of Race.

**32. RIGHTS TO USE NAMES AND LIKENESSES**

Where consent has been given for imagery, competitors grant to the Organising Authority without payment the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event.

**33. RISK STATEMENT**

RRS 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is her's alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

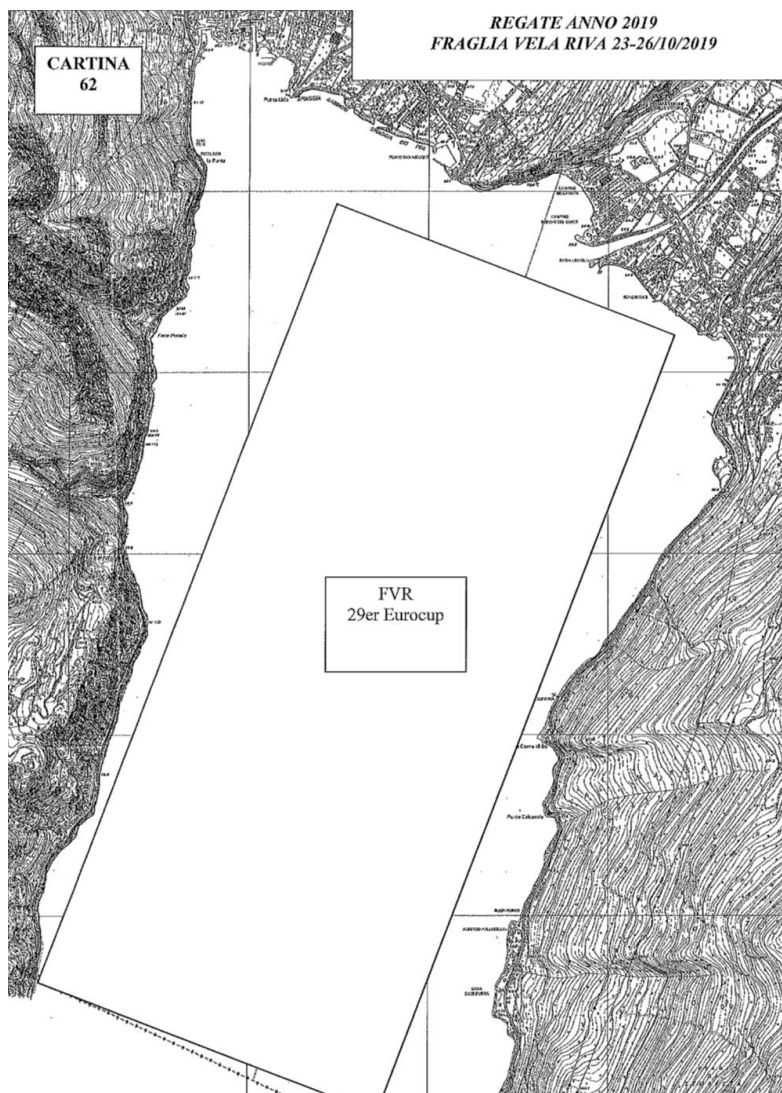
- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances
- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the event and to attend any safety briefing held for this event.

### 34. INSURANCE

Each participating boat shall be insured with valid third-part insurance with a minimum cover of Euros 1.5 million per event or the equivalent.

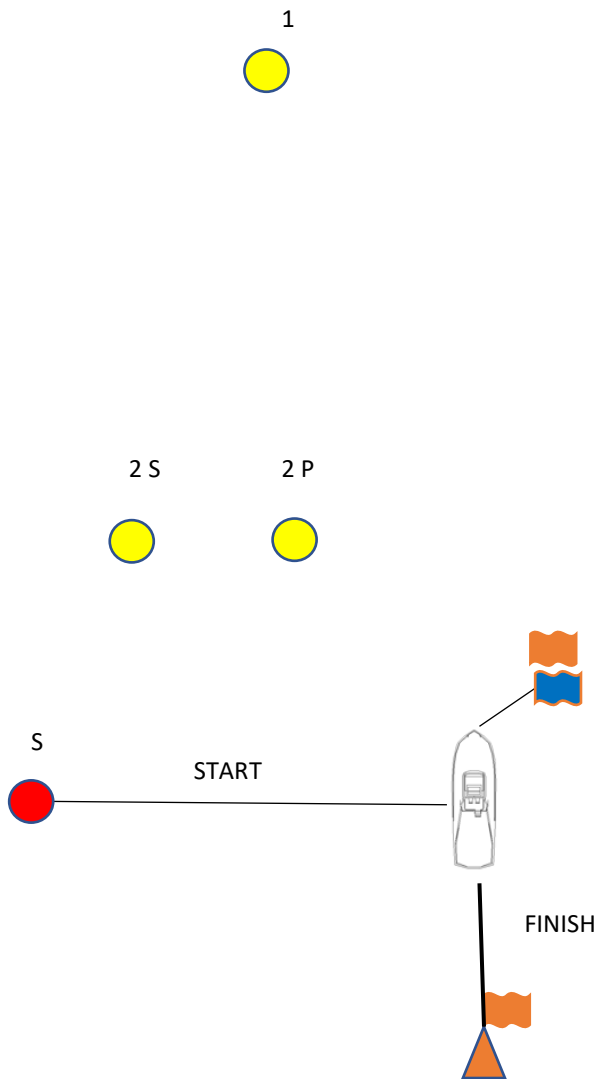
