NOTICE OF RACE

The notation '[DP]' in a rule in the NoR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

1. RULES

1.1 The regatta will be governed by the rules as defined in the:

- Racing Rules of Sailing (RRS)
- IRC Rule 2019
- Class Rules
- International Regulations for Preventing Collisions at Sea
- Notice of Race (NOR) & Sailing Instruction (SI)

1.2 If there is a conflict between languages the English text will take precedence.

1.3 If there is a conflict between the NoR & SI, the SI will take precedence. This changes rule 63.7.

1.4 No limit to the number and weight of crew, however all participants must adhere to their registry and insurance.

2 ADVERTISING

2.1 Competitor advertising will be restricted in accordance with WS Regulation 20, Advertising Code.

2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY AND ENTRY

3.1 The regatta is open to all self-righting Keelboats & Multihulls in the following classes:

- IRC – Boat with valid IRC 2018/19 certificate
- PY – Performance Handicap numbers apply
- Multihull – Performance Handicap numbers apply

3.2 Boats entering under PY shall be given a Performance Handicap rating issued by the OA, no redress shall be allowed.

3.3 The allocated PY rating may be adjusted at the sole decision of the OA if the rating previously granted is considered to be unrealistic by the Committee with reference to the rest of the fleet. (It is the intention of OA is to give all PY boats an opportunity to be competitive).



- 3.4 Eligible boats may enter by completing the “Entry Form” and sending it, together with the required fee to the Organising Authority by the **10th January 2020**.

4 FEES

- 4.1 Entry fees for this regatta are as follows:

- a) Yacht, Multihull & various keelboat IDR5million per boat inclusive of skipper
- b) Crew IDR1million per person

Entry fee is inclusive of Indonesia clearances, port & harbor taxes where necessary and relevant, and inclusive of berthing from 10th to 24th January 2020.

- 4.2 All entries must be accompanied by a copy of the boat’s current registry, insurance, MMSI and rating certificates. Registration will be closed on 10th January 2020 at 1600hrs.

5 SCHEDULE

A maximum of 7 races are scheduled for this regatta. There's no limit to the number of races that may be sailed each day.

6 SAILING INSTRUCTIONS

The Sailing Instructions with full course details will be made available from **10th January 2020** at the Nongsa Point Marina & Resort and e-mailed to all registered participants.

7 MEASUREMENT & COMPLIANCE (IRC)

- 7.1 All boats sailing under the IRC Rule must display their Black Bands on the mast and boom and make available their sail wardrobe for measurement before race commencement [DP]



7.2 The Rating Authority or a boat's Rule Authority may require a boat to be submitted for measurement at any time without giving reasons. Measurement will be undertaken by authorised measurers of IRC South East Asia. A new certificate will be issued by the Rating Authority based on the new measurement data.

7.3 It is at the discretion of the Organising Authority to appoint a qualified IRC measurer for random boat inspections.

8 COURSES

The courses to be sailed will be described in the Sailing Instructions.

9 PENALTY SYSTEM

For all classes Rule 44.1 is changed so that the Two-turns Penalty is replaced by the One-Turn Penalty.

10 SCORING

10.1 1 race is required to be completed to constitute a Regatta.

10.2 A maximum of 7 races are scheduled for this Regatta;

- (a) When 4 or fewer races have been completed, a boat's series score will be the total of her race scores.
- (b) When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

11 PRIZES

Prizes will be awarded if 4 or more entries are received:

Keelboat IRC	1 st to 3 rd
Keelboat PY	1 st to 3 rd
Multihull	1 st to 3 rd

OR :

When there are 3 entries – two (2) prizes will be awarded

When there are 1 to 2 entries – one (1) prize will be awarded

12 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

13 INSURANCE

Each participating boat shall be insured with valid and adequate third-party liability insurance.

17 RADIO COMMUNICATION



Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. [DP]
