FACTS FOUND

- 1. Yellow race 1.
- 2. Wind average 6-7 knots at race committee boat, 5-6 knots at top of the course, flat water.
- 3. Some sailors completed the race without any capsize or recovering situation.

- 4. Some sailors were able to foil from the starting sequence until the finishing line.
- 5. No major wind shift in direction or strength was detected during the race.
- 6. Some sailors were unable to complete the course.
- 7. After racing, the race committee checked the tracking and footage and decided not to abandon the race, considering the consequences for all the sailors in the race.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 62.1(a), 32.1, definition of 'rule'

- 2. There was neither an improper action nor omission of the race committee, as to whether to abandon or not the race is their decision under RRS 32.1. Therefore, the requirements for redress in RRS 62.1(a) are not met.
