

• Protest #16 was posted on the Official Notice Board at 14:15 HKT

Protest #21 was received by the Race Office 15:49 and posted on the Official Notice Board at 16:35 HKT

• The Protest Time Limit was 16:18.



- Port Shelter Mark is an inflatable buoy located at 22 17.60' N 114 20.80' E. Trio and Table Marks are islands and are clearly charted.
- The rhumb line from Port Shelter Mark to Table Island clearly (visually and on marine chart) passes to the east of Trio Island, by some 880m. e.g. Does not touch Trio.
- List of boats who sailed from PSM and looped Trio Island on their port side and then sailed to Table Island per Track A on the diagram:
  - IRC B division: Nightshift, Tipsy Easy
  - HKPN A division: Temujin, Ichiban, Good Vibrations, Ricochet (RET), Bluefin
- List of boats who sailed directly from PSM to Table Island per Track B on the diagram.
  - IRC B division: Rampage, Kiasu, Kingsman, Daydream, H3O (RET), Juggerknot, Bad Idea Bears on Full Tilt, Intrigue Plus, Outrageous
  - HKPN A division: Scintilla, Bits & Pieces, Minnie the Moocher, Baring Asia 2 (RET), Amaze
- Nightshift and Temujin protested.
- Minnie the Moocher requested redress citing "...the course was misleading." (Case #23)

• The RRS definition of 'Sail the Course' defines in part that;

"A boat sails the course provided that a string representing her track from the time she begins to approach the starting line from its prestart side to start until she finishes, when drawn taut... ...touches each mark designated in the sailing instructions to be a rounding mark..."

• Track A complies with the definition of 'Sail the Course' as required in RRS 28.1. Conversely, Track B does not comply with the definition of 'Sail the Course', since the 'string' does not touch Trio when pulled taut.

### DECISION

Date & Time: 2021-07-28 20:10 HKT Each boat who did not loop Trio Island to port (Track A) failed to 'Sail the Course' as required and broke RRS 28.1. Those boats shall be DSQ in Race 5, except that:

H3O (IRC B), Baring Asia 2 (HKPN A) and Ricochet (HKPN A) had retired prior to the hearing and shall not be further penalised, per RRS 64.2(a).
