



NOTICE OF RACE

**SL SRA 420 League Regatta - Fireball
Grade: 5A, Level L
15 and 16 January 2022**

**Organizing Authority: Société des Régates
d'Antibes**

Preamble:

Depending on the evolution of the health crisis, the Organizing Authority may modify the conditions of the notice of race without prior notice.

*Digital means: **WhatsApp** will be used as the "Official Board". There will be no physical display. Competitors will be required to provide a means of receiving these communications. This will not be subject to a claim for redress. This changes RRS 62.1(a).*

Depending on the evolution of the health crisis, the Organizing Authority may modify the conditions of registration and/or eligibility.

In the unprecedented context of "COVID 19", the Organizing Authority may cancel the event.

1- Barrier gestures (DP):

- Before confirming his registration, each crew member must have individually completed the health self-questionnaire available at the following **address**

- All participants in the SRA 420 - Fireball league regatta: organizers, referees, racers must be in possession of masks and a bottle of individual hydro-alcoholic gel, from the arrival to the departure of the competition site, on land and on the water.
- Groupings of people must respect the gauges defined by the public authorities. Whenever possible, any grouping of people should be avoided when the physical distance (2 m) cannot be respected.
- The mask must be worn at all times. Only the people involved in the competition, the referees, the sailors and the accompanying persons (coaches...) when they are on the water, may not wear a mask.
- The barrier gestures must be scrupulously respected as soon as a person involved in the SRA 420 Fireball league regatta is not on the water. The non-observance of the instructions given or transmitted by the organizer, including orally, may lead to a protest at the initiative of the Jury.
- Reasonable actions by the event organising authority to implement COVID-19 guidelines, protocols or legislation, even if subsequently found to be unnecessary, are not actions or omissions and shall not give rise to a claim for compensation (this amends RRS 62.1(a).

2. COVID referent and crisis unit in case of suspected contagion :

a- Referent COVID :

The COVID referent will be Julien Lacaze.

b- COVID cell in case of suspected contagion :

- The COVID cell will be composed of the / of :
 - o AO representative.
 - o President of the Race Committee, Olivier De Turckheim
 - o President of the Jury or Chief Umpire,
 - o COVID referent, Julien Lacaze
 - o Any competent person to assist this cell and take the necessary measures.

- Operation :

This unit will follow the recommendations set out by the Ministry of Sports in the document "Health protocol for the management of suspected and positive Covid-19 cases / sports movement": <http://sports.gouv.fr/IMG/pdf/ficherentreeproctocolesanitaire.pdf>

This cell must be informed of any suspicion of COVID before, during and after the competition. This unit shall deal with any suspected COVID and decide what action to take in such a case. Any decision of the VIDCO cell is final and must be adhered to, in accordance with this appendix and the sections of the Notice of Race and Sailing Instructions that deal with the VIDCO health crisis.

3. Consideration of the Covid19 Risk by participants :

By registering to the SL SRA 420- Fireball league regatta, each competitor certifies that he/she is aware of the Covid-19 risk, as well as those accompanying him/her, and that he/she has taken it into account.

Each competitor and accompanying person is fully aware of this fact:

- the measures of hygiene and physical distancing, known as "barrier gestures" to be observed in all places and at all times, as well as the additional provisions published by the Ministry of Sports, and undertakes to respect them,
- the risk of contamination accentuated by the proximity of another person, in particular when sailing on a crewed or double-handed boat, or any other situation of proximity of less than one meter, without the appropriate reinforced protection,
- that despite the implementation of reinforced protective measures, the practice may expose to a health risk, in particular contamination by Covid-19,
- that despite the measures taken and the means employed, the host establishment, structure/club cannot guarantee total protection against exposure and contamination with Covid-19. It releases the Organizing Authority from any responsibility in case of contamination,
- that all these measures are aimed at preserving the health and physical capacities of the competitors, accompanying persons and members of the Organizing Authority participating in the regatta.

4. Suspect COVID 19 :

"A boat with a suspected case of Covid 19 in its crew must immediately withdraw from the race/competition and comply with the directives of the health authorities. Failure to do so may result in disqualification. If deemed necessary, the Jury may also open an investigation under rule 69.

1. RULES

The regatta will be governed by :

- 1.1. the rules as defined in the Racing Rules of Sailing.
 - 1.2. the national requirements applying to foreign competitors as specified in the annex "Prescriptions" if necessary,
 - 1.3. Federal regulations.
- the individual mini regatta will not count for the interregional selections.

2. ADVERTISING

In application of ISAF Regulation 20 (Advertising Code), as modified by the F.F.Voile Advertising Regulations, boats may be required to carry advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND REGISTRATION

- 3.1 Entries will be made via the website of the Société des Régates d'Antibes
- 3.2 Competitors (each member of the crew) holding a FFVoile licence must present at the time of their registration :
 - their valid ClubFFVoile license mentioning "competition".
 - a parental authorization for minors
 - if necessary, the authorization to carry advertising
 - the certificate of tonnage or conformity

Foreign competitors who are not licensed in France will have to prove that they belong to a National Authority member of the ISAF.

4. FEES TO BE PAID

The required rights are as follows:

5.1. Confirmation of entries :

The place of unloading and registration is at the sailing base of the Société des Régates d'Antibes (boulevard James Wyllie in Antibes)

6. RACING INSTRUCTIONS

The race instructions and any annexes will be :

- available upon confirmation of registration
- displayed according to the Federal Prescription

7. THE TRAILS

The course to be completed is as follows: Trapeze course.

8. RANKINGS

8.1. The number of races to be validated to constitute a series is 2 for the fleet race. At the end of these races, a 420 and Fireball ranking will be published

9. RADIO COMMUNICATION

Except in case of emergency, a boat shall not make radio transmissions while racing nor receive radio communications that are not receivable by all boats. This restriction also applies to mobile phones.

10. PRICE

Prizes will be distributed as follows: First 3 of the regatta for the 420 and Fireball series.

11. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. The decision to enter a race or to remain in the race is their sole responsibility.

The organising authority will not accept any responsibility for any damage to property, injury or death in connection with the regatta, either before, during or after the regatta.

12. INSURANCE

Foreign competitors who are not FFVoile licensees must provide proof of valid civil liability insurance with a minimum cover of 1.5 million Euros.
