1. See Case 02 (Class 4 IRC results). Decision 10.06.2023 and information emailed to competitors on 13.06.2023
2. On 13.06.2023, the owner of 3335 ("Bite the Bullet") brought to the attention of the OA that the incorrect IRC TCFs had been used for 3335 and 33301.
3. On 14.06.2023, HYC Results confirmed that the incorrect TCFs were used for 3335 and 33301. Revised provisional results attached.
