## **QUESTIONI PROCEDURALI**

1. Giorgio Bolla, member of protest committee has declared his Col (published)

- 2. ITA 9086 is member of the same Sailing Club of Giorgio Bolla, where Giorgio Bolla is a member of the Board.
- 3. Giorgio Bolla doesn't partecipate to the hearing and is replaced in the PC for the current hearing by the Officer Lucia Ranza.
- 4. ESP did not come to the hearing, the hearing proceeded according to RRS 63.3(b).

### **FATTI ACCERTATI**

- 1. The incident occured 10" after the starting signal of race n.6.
- 2. Choppy sea, 10 knots.
- ESP and ITA were sailing on stb, with ESP overlapped to leeward and about 3/4 hull length ahead of ITA.
- 4. The boats were approximately 20cm apart.
- 5. ESP suddenly tacked and assumed a close-hauled course on port.
- ITA luffed immediately.
- 7. A contact with no damage occured between ESP's starboard amidship side and ITA's port amidship side.
- 8. No boat took penalty-turns.

#### **CONCLUSIONI E REGOLE APPLICATE**

Rules: RRS 10, RRS 14

- 1. ESP on port failed to keep clear of ITA on starboard, and broke RRS 10.
- ESP did not avoid the contact even if it was reasonably possible, and broke RRS 14.
- 3. It was not reasonably possible for ITA, the right-of-way boat, to avoid contact with ESP when it was clear that ESP was not keeping clear. ITA did not break RRS 14.
