PROCEDURAL MATTERS

- Protest 5 discussed together with protests 3 and 4
- Protest 3 was presented by JAP 56 in time at 17.03 and, for an error in the filling the on-line form, it was presented another two times (protest n° 4 and protest n° 5)

FACTS FOUND

1. Incident occurred in the offset mark of the second race
2. Wind 20kts, wave 0.5-1.0m
3. JAP 56 sailed starboard from the top mark to the offset mark, clear ahead of GER 77 and AUS 551
4. GER 77 sailed windward, overlapped at a distance of 1m to AUS 551
5. AUS 551 and GER 77 sailed clear astern of JAP 56, one boat length to JAP 56
6. JAP 56 entered in the zone not overlapped, clear ahead and windward of GER 77 and AUS 551
7. AUS 551 and GER 77 entered in the zone both overlapped, AUS 551 was the inside boat
8. AUS 551 and GER 77 rounded the mark, AUS 551 one meter to the mark, and GER 77 one meter windward to AUS 551
9. JAP 56 rounded the mark windward to GER 77 and AUS 551 and it luffed and changed his course
10. No contact, no boats take a penalty
