Scoring Inquiry:

I'm not seeing how the ORC corrections match the Predominantly DW Heavy ratings. Phoenix would owe Blue Jay time, but the correction suggests Blue Jay owes Phoenix. I believe Ripple should have owed Phoenix about 78 minutes. We beat them by 58 minutes, so that should be a delta of 20 minutes, but the scoring shows 61 minutes. Maybe a review of the scoring for the Leg in general is needed?

Response:

RC has done the following:

1. Confirmed the Predominant Downwind High ratings for the three boats by verifying against the certificates.
2. Cross checked the certificates to the ToT correction factor used in the scoring software.
3. Manually verified the corrected time with the correction in the software.

RC Concludes: The corrections are correct.
